**MILITARY EXEMPT:** Must include L.E.S. and copy of registration with this form. State of residence must be out of state; or, if UT resident, provide letter from commanding officer showing the car's year, make, model, VIN#, owner's name, and stating the military person is stationed out of state and has the car with them.

**VETERANS EXEMPT:** May provide a DD214 in place of the L.E.S.

### **For Refunds of Registration and Off Highway to Street Legal:**

Refund requests will need to be made separately for the County's portion and the State's portion of your refund.

To request a refund from the Utah DMV for the State portion, go online to [mvp.tax.utah.gov](http://mvp.tax.utah.gov) and complete the 'online request for refund. If you are unable to submit the request online, please contact the DMV at 801-297-7780 for Instructions to submit.

The full amount was collected by the DMV/State, so if they approve or deny the refund, Davis County will follow suit with their decision. If the refund request is approved by the State, a refund from Davis County will be mailed to the mailing address provided on the front of this form.
