Qualified Political Parties and Local School Boards	Begins Friday, March 13, 2020 Ends at 5:00 p.m., Thursday, March 19, 2020
Judges	Begins Wednesday, July 1, 2020 Ends at 5:00 p.m., Wednesday, July 15, 2020

The period to declare intent to gather signatures for qualified political party candidates begins on Thursday, January 2, 2020 and ends at 5:00 p.m., Thursday, March 19, 2020.

Candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.
