# Stormwater Pollution Prevention

### Tips for Pools & Spas



### Areas of Concern:

- Filter Backwash
- Draining Pool Water
- Algaecides
- Chemical Storage



Storm drain water is NEVER treated.



### **Chemical Storage**

Store pool and spa chemicals in a manner to **prevent leaks and spills**, preferably in a covered enclosure.

- Chlorine
- Bromine
- Cleaning Agents
- Algae Control
- Coagulants/Clarifiers
- pH-adjusting chemicals

## Stormwater 101

Clean wetlands and healthy streams are important to Davis County. The water from parking lots, driveways, and streets flow into the storm drain which goes <u>untreated</u> into the streams, wetlands, and eventually enters the Great Salt Lake. Pollution entering the storm drain makes the waterways unsafe for people and wildlife. Following these management practices will prevent pollution, comply with regulations, and protect public health.

### **Draining a Pool or Spa**

Drain only when chlorine levels are very low, not detected by a chlorine test kit (less than 0.019 mg/l).

- Re-use water for landscaped areas whenever possible; avoid allowing the water to drain on neighboring properties
- Otherwise, drain to sanitary sewer—coordinate with your local sewer district (see numbers below).
- If above options are not feasible, drain only clean pool water to storm drain (or curb and gutter) that has been de-chlorinated and chlorine is not detected with a test kit.

### Algaecides

Avoid copper-based algaecides such as copper sulfate. Copper sulfide at a concentration that is a mild irritant to humans is fatal to fish!

### **Cleaning Filters**

Direct any filter backwash to a sanitary sewer. Never discharge filter backwash to a storm drain! The sanitary sewer system takes wastewater to a treatment plant where it is treated before continuing to the Great Salt Lake.
