GENERAL RULES:

1. Animals will be accepted on Tuesday, August 11th from 5:00 pm – 8:00 pm.
2. Animals will be released Saturday, August 15th at 9:00 pm.
3. Judging will begin on August 12th at 9:00 a.m.
4. All entry fees must be paid before animals are allowed in barn. Entries must be marked “youth” (18 and under) or “adult”.
5. Rabbits must have a permanent tattoo in the left ear. Cavies must have an ear tag. If your entry lacks a tattoo or tag, contact the barn supervisor.
6. Sick animals will be refused admittance or will be removed from the show.
7. Animals will be fed and watered by barn personnel.
8. The Davis County Fair management will not be responsible for any loss, damage or death during the show; however, every precaution will be taken to ensure against such hazards.

All recognized ARBA showroom classes will be accepted. Exhibitors need not be members of ARBA to enter.
