This AGREEMENT is made this ____ day of _____, 2019 between Davis County ("County"), a governmental entity and _____ ("Donor").

Whereas, Davis County Commission hosts the Youth Charities Cup Golf Tournament each year to support youth programs in Davis County and

Whereas, the 2019 Youth Charities Cup Golf Tournament will take place on June 7, 2019; and

Whereas, Donor has informed the County of his/her/its desire to make a financial donation towards the 2019 Youth Charities Cup Golf Tournament.

IT IS HEREBY AGREED UPON AS FOLLOWS:

1. Donor agrees to provide the County with a financial or in-kind donation in the amount indicated below:
