"Qualifying active duty military service" means at least 200 days in any continuous 365 day period of active duty military service outside the state in an active component of the United States Armed Forces or a reserve component of the United States Armed forces, if the days of active duty military service: (a) were completed in the year before an individual applies for this exemption; and (b) have not previously been counted as qualifying active duty military service for purposes of qualifying for this exemption or applying for this exemption.
