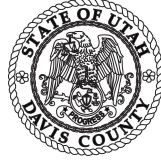

Dates for filing for these offices are as follows:

Qualified Political Parties and Local School Boards	Begins Monday, February 28, 2022 Ends at 5:00 p.m., Friday, March 4, 2022
Judges and Justices	Begins Friday, July 1, 2022 Ends at 5:00 p.m., Friday, July 15, 2022

The period to declare intent to gather signatures for qualified political party candidates begins on Monday, January 3, 2022 and ends at 5:00 p.m., Friday, March 4, 2022.

Qualified Political Party Candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.
