Cannot operate without computer-computer cannot perform functions outside machine. 3. Able to perform multiple functions; is controlled by programmable central processing unit. 4. Cost of machine/computer combined is depreciated as unit for tax purposes. 5. Capabilities cannot be expanded by substituting more complex computer for original.
03	Short Life Equipment	Alarm systems, ATM's, Bank Drive-up Windows, Cameras, Carpet, Cash Registers - manual, Emissions Testing & Engine Analysis Equipment, Fax & Office Machines, Microwave Communication Equipment, Music/Sound Systems, Photo Processing Equipment, Rent-to-own, Pneumatic Tube Systems (Banks), Reservation Terminals, Small Eq Rentals, Shopping Carts, Phone Eq, Vending Eq, Video Game Machines.
05	Furniture/Fixtures	All furniture (motel/hotel/office), Bars/sinks, Beauty-Barber Shop fixtures, Booths, Cabinets/Shelving, Cashier Islands, Check-out Counters, Display Cases/Racks, Mobile type buildings, Musical Instruments, Partitions, Sheds, Signs, Sinks, Tanning Booths, Theater Seats.
06	Light/Med/Hvy Dty Trucks	All NON-PLATED light, medium and heavy-duty trucks.
08	Machinery/Equipment	All Medical, Dental, Optical Eq & Instruments, Exam Tables/Chairs, Hospital Eq, Microscopes, Optical Eq, Mesoptometers, Lensometers, Sterilizers, X-Ray machines. 25	Aircraft Parts Manufacturing	Aircraft Parts: Manufacturing Jigs, Dies, Molds, Patterns, Manufacturing Taps & Gauges, Test Equipment & Fixtures (Manufacturing Jigs, Dies, Molds, etc. in Class 1).
