#2022-593 **4. Memorandum of Understanding with Saltaire Farm Equestrian Center for a working relationship between Saltaire Farm and the County in preparing for and responding to disasters in Davis County at all levels** — *Presented by Animal Care Director Ashleigh Young*

It was explained that this is for the Davis County Animal Care's Emergency Action Plan to assist Animal Care with livestock in the event livestock would need to be removed from an area. This will allow Animal Care to Utilize Saltaire Farms' facilities, trucks, and trailers.

**Commissioner Elliott** asked where Saltire Farms is located. Ashleigh advised they are located in North Salt Lake.

The agreement period is from 10/07/2022 to 10/07/2023.

**Commissioner Stevenson** asked Ashleigh if any of the rabbits that get adopted are ever returned to Animal Care. It was explained that the rabbits are adopted out to pet homes so it is not likely the pets will be returned. Ashleigh advised that Animal Care had a lot of baby bunnies in September.

Commissioner Elliott invited comments from the dais.

**Commissioner Kamalu** stated she attended the 28th Annual Utah Water Summit. She advised there was a lot of great information given at that Summit. Utah residents have been paying attention to non-functional turf and conservation given Utah is the second driest state. She advised there is a research project going on right now with a professor at Brigham Young University and his master's student on what the working definition of a reliable water supply is, what it does, and how it is evaluated. She stated how interested she is to hear about the outcome of that research project as they have studied other jurisdictions in the United States. She mentioned that there is also a Great Salt Lake Summit, which was held twice this year.

**Commissioner Kamalu** announced that Preservation Utah awarded Davis County for the restoration of the Memorial Courthouse. The Commissioners, Facilities Director Lane Rose, the contractor, and the architect were invited to be a part of that event and accept that award. She commented on how interesting it was to see the things in Utah being preserved and see that the Davis County Memorial Courthouse stands out. Commissioner Kamalu commented on how well the Memorial Courthouse project turned out and the good job done by everyone involved as it is now being recognized by the State.
