WORK SESSION DISCUSSION

Discussion of the Proposed Ordinance Regarding Salary Provision for Elected Officials

This item was presented in a Commission meeting on October 27, 2022, and tabled that same day to allow for further discussion to include the elected officials. This meeting enables that conversation to be held in an open forum.

Commissioner Kamalu gave it some background. The elected officials do not get merit increases but do get cost of living increases. The Commission has taken action outside those processes to give a salary increase to specific elected officials when their pay has lagged. Those increases had nothing to do with the person but the position and the good of the county. The Budget Committee transparently considered those increases during Budget Committee meetings, open to the public. The three elected officials most recently adjusted were the Clerk/Auditor, the Sheriff, and the County Attorney.

David Cole and Neal Geddes drafted the proposed ordinance regarding salary provisions to address the issue of lagging salaries for elected officials and provide a structural change to the process instead of leaving the decisions up to the Commissioners to address.

Sections 2.80.010, 2.80.020, and 2.80.030 read: *The purpose is to ensure that the elected officials are fairly and adequately compensated and, in most cases, should not earn a salary less than the highest paid deputy or employee in his or her office. They should be compensated fairly that accurately reflects their skills, experience, and administrative and professional job duties. In the event the salary of a County Elected Official falls below the official's highest paid deputy or employee within their office, the County Elected Official may elect an automatic increase that places the County Elected Official's salary 1% above the official's highest paid deputy or employee.*

COMMISSIONERS' MINUTES – DAVIS COUNTY

Each year the Legislative Body shall hold a public hearing in accordance with Section 17-16-14, Utah Code Annotated to address changes to the salary of any County Elected Official that opted into the automatic increase described herein.

Essentially, the elected official would have to opt into this, which would only apply to elected officials, not department heads. There was a significant amount of discussion on the matter that included the opinions of several County elected officials. The Commission will consider all of them, and this item will likely come before the Commission again for approval.
