WORK SESSION DISCUSSION

Discussion of the Animal Care Funding Model Moving into 2023 and Beyond—Presented by Ashleigh Young, Animal Care Director

Curtis Koch said the Animal Care shelter was constructed in 1986 and had no longer met the needs of a growing Davis County. He said a feasibility study would be completed in September, but the budget process for 2023 will have already begun by then. He presented several ideas on budgeting for the department's needs for 2023 and beyond. They can have a "flat-line zero" or wait for the feasibility study outcome, go for a General Obligation (GO) Bond, and put it to the people's vote to decide what to do with Animal Care. The GO Bond would be for capital improvement (to build a new shelter.) Another option would be to go through Truth in Taxation, which would lock in the tax rate after the bond is gone. As departments go into the budget process, the Commission will need to instruct Ashleigh on the direction in which to go.

The feasibility study is specifically looking at the condition of the current facility, if a new facility should be built to replace it or built in another location, and looking at staffing levels for operations.

The Commission will not be able to make a decision today. Still, Curtis said he wanted to present this information to them to prepare them to decide once the study is complete and give Ashleigh that direction. Curtis said he could run some numbers based on the various scenarios to see what the costs would be. If they decide to go for a tax increase, they would have to inform Curtis by September 1st to notify the Treasurer and send a parcel-specific mailer with a not-to-exceed amount to all tax-payers.

COMMISSIONERS' MINUTES – DAVIS COUNTY

The original discussion with the cities was they would pay the capital costs for the next 10-20 years, but that went away with the new legislation, and the entire burden is now on the County. This is a municipal-type service which makes it a unique situation.
