

GREAT SALT LAKE BIRD FESTIVAL DONATION AGREEMENT

This AGREEMENT is made this ____ day of _____, 2024 between Davis County (“County”), a governmental entity and _____ (“Donor”).

Whereas, Davis County hosts the Great Salt Lake Bird Festival each year to increase public awareness and pride for birds found on and near the Great Salt Lake and northern Utah; and

Whereas, the 2024 Great Salt Lake Bird Festival will take place on May 16-19, 2024; and

Whereas, Donor has informed the County of his/her/its desire to make a financial or in-kind donation towards the 2024 Great Salt Lake Bird Festival.

IT IS HEREBY AGREED UPON AS FOLLOWS:
