

**EXHIBITORS “Schedule A”**  
**CONDITIONS, RULES AND REGULATIONS**  
**ANTELOPE BY MOONLIGHT BIKE RIDE**  
**Friday, July 11, 2025**

This form must be returned by Friday, June 13, 2025 — Applicants will be reviewed by Davis County and if selected the applicant will be notified and the attached space contract will be approved and signed by the County and returned.

Antelope by Moonlight Bike Ride (Ride) Exhibitor Booth Locations:

All booth locations will be located outside rain or shine. The exhibitor fee is \$75.

Antelope Island State Park Marina (Marina): All pre-party/Marina exhibitors must be set-up between 4:30 PM and 6:30 PM and remain open from 7:00 PM to 10:00 PM on Friday, July 11, 2025. No materials may be removed during the operating hours of the pre-party. The exhibitor must restore the booth area to its original form before vacating. Exhibits may be removed from the Marina after the Ride starts at 10:00 PM. All exhibits and articles must be removed before 2:00 AM on Saturday, July 12, 2025.

Antelope Island State Park - Garr Ranch (Ranch): All Ranch exhibitors must be at the Ranch by 8:30 PM and set-up by 10:00 PM. Ranch exhibits must remain open from 10:00 PM to 1:00 AM. Road access to leave the Ranch will be closed from 9:00 PM until the Ride ends. Antelope Island State Park Trail Patrol are the only authorized agents to open the road to vehicles. The exhibitor must restore the booth area to its original form before vacating. Exhibits may be removed from the Ranch after 1:00 AM and trail patrol has opened the road to vehicles. All exhibits and articles must be removed before 2:00 AM on Saturday, July 12, 2025.

Character of Exhibits: Exhibitors shall remove any objectionable displays and materials as determined by the ride director at exhibitor's costs. The distribution of printed matter and other articles is restricted to the space occupied by the exhibitor. Exhibits deemed unsuitable or objectionable will not be allowed. Exhibitor, by signing the Space Contract, authorizes the ride director to inspect all exhibits and all materials and articles intended for distribution. Exhibit booths must be maintained in clean and proper order at all times by the exhibitor.

Losses: Davis County, Ride and Antelope Island State Park (Park) are not responsible for loss of exhibits before, during or after the Ride and therefore the exhibitor is responsible for insurance to cover any loss. Exhibitors are urged not to leave valuable merchandise or items unattended at any time.

Noise: No loudspeaker, amplified or other sound device can be used in the exhibit space without prior written approval of the ride director. Excessive noise from generators, high speaker systems, stereos, televisions, or other sources are prohibited.

Taxes: Exhibitors engaging in direct sales shall be responsible directly to the Utah State Tax Commission for the collection and submission of sales taxes.

Right to Move: Ride reserves the right to move an exhibitor from one location to another regardless of their space request or previous assignments.

Electricity/Internet: Electricity and internet connections are not available. Please plan accordingly.

Fire Hazards: Exhibitors may not have any open flames except as outlined in the following sentence. Only food vending exhibitors may use flames as part of a cooking device used to heat or cook their food. Every exhibitor with a cooking, warming or heating source is required to have a fire extinguisher in their booth at all times.

Use of Propane: Exhibitor is responsible for anything related to the use of propane. Propane tanks and hoses may be inspected at any time by the Park, Davis County Health Department, or Syracuse City. Tanks that are outdated or that have outdated regulators or unsafe hoses shall not be used by the exhibitor. Unsafe items must be fixed or replaced by the exhibitor at their own cost and the exhibitor will not be reimbursed for any expenses or lost revenue.

Food Vendor Permits: The exhibitor shall display a copy of the current Davis County Food Handler's permit for each person who will be serving food at the booth during the Ride. Each exhibitor must obtain a 'Temporary Food Service Establishment Permit' from the Davis County Health Department and provide the permit number prior to the Ride.

**SPACE CONTRACT FOR EXHIBITORS  
ANTELOPE BY MOONLIGHT BIKE RIDE**

The undersigned exhibitor submits this contract to Davis County for authorization to use a space at the Antelope Island Marina or Garr Ranch during the Antelope by Moonlight Bike Ride (Ride) and acknowledges and agrees to be bound by the authorized use and shall be subject to the permit period and conditions set forth in this agreement and "Schedule A".

2. All booths will be located outside rain or shine. Exhibitor must provide their own weather proofing (e.g. tenting, awning, sun shade), power, and light source.

4. Booth Rental: No booth equipment rental is available. Exhibitors are responsible for bringing their own booth setup which may include tables, chairs, tenting, etc. for an approximate 10'x10' space.

5. Responsibility: Davis County, Ride and Antelope Island State Park (Park) will not be responsible for any loss by fire, theft, windstorm, explosion, natural phenomena, and cancellation of events, loss of occupancy or any other cause incurred by the exhibitor. The exhibitor shall be held responsible for damages caused by the exhibitor's operation and agrees to indemnify and to hold Davis County, Ride and Park harmless from any claims or liability arising from the activities, conduct or negligence of the exhibitor or any of the exhibitor's agents, employees or officers.

6. Compliance: The exhibitor shall comply with all applicable state and local health and other laws, rules, regulations and obtain and comply with all required permits, including attendance at any required orientation or training courses.

7. Conditions/Rules: The authorization for the use of the space is subject to the conditions, rules and regulations set forth in "Schedule A" or as may be amended.

8. Assignment: The exhibitor shall not assign or sublet any part of this lease or space.

9. Exhibitor Fee: \$75 booth fee payable by mail to Antelope by Moonlight Bike Ride, 28 E. State Street, Suite 214, P.O. Box 618, Farmington, UT 84025. Payment by phone to 801.451.3272 will incur a \$5.00 service fee. The exhibitor agrees to pay for all costs of collection, default, breach or enforcement hereunder, including reasonable attorney fees.
